Past Grand Exalted Ruler Leonard J. Bristol, Past Grand Exalted Ruler Peter T. Affatato, and Past Grand Exalted Ruler Amos A. McCallum proudly announce the Area 1 selection of NYS Past President David R. Carr as Endorsed Candidate for Grand Exalted Ruler for 2011 - 2012.

David was initiated into the Whitehall, NY, Elks Lodge #1491 in February, 1975 and served as Lodge Organist and Chaplain. He transferred his membership to Ticonderoga Lodge #1494 in 1978 and served as Lodge Chaplain, Esquire and Organist. He proceeded through the chairs to serve as Exalted Ruler in 1989, PER Association Chairman in 1990, and as Lodge Trustee from 1988 - 2005. He served as Lodge and District Public Relations Coordinator and Editor from 1988 - 1996.

David served the New York State Elks Association as State Vice President in 1990 - 1991, as Community Activities Chairman from 1995 - 1997, as State Editor from 1997 - 2002, as State Secretary from 1999 - 2009, and as State President from 2009 - 2010. David introduced the Dictionary Project to Elks in New York State in September, 2003, and to the Grand Lodge in July, 2004.

At the Grand Lodge level, David served as District Deputy Grand Exalted Ruler in 1994 - 1995 and as a member of a Grand Lodge Steering Committee and Trustee Chairman overseeing financial assets of a defunct lodge from 2002 - 2009. David served on the Board of Grand Trustees as Secretary from 2006 - 2008, Home Member from 2008 - 2009, and as Vice Chairman for 2009 - 2010.

David was born and raised in the town of Moriah, New York. Following high school graduation in 1960, he successfully completed a four-year NYS accredited Industrial Electronics Apprenticeship training course in addition to several college-level courses and seminars in Advanced Writing, Business, Advanced Math, Computerized Electronic Control Systems, Power Controls. Distribution and Labor/Management Auditing and Finance, Workplace Health & Safety, and IRS and State Attorney General Tax Exempt Charities Symposiums. David retired from International Paper in Ticonderoga in 1999 following thirty-seven years of dedication to industrial electronics and workplace safety.

At the community level, David has served as a member or officer of several conservation organizations,

Hospital Board, School Board, Volunteer Fire Company, Board of Fire Commissioners, Kiwanis Club, Knights of Columbus, and Jaycees. He has served as Publications Officer of his local U.S. Coast Guard Auxiliary since 2001, and as a member of the Department of Homeland Security since 2003.

In 2008, David was awarded President Bush's USA Freedom Corps Volunteer Service Award by then-Grand Exalted Ruler Paul Helsel.

David resides in Crown Point, NY, with his wife, Mary-Lenn (Penny), a retired English teacher. They have four children and eight grand-children. David and Penny attend the Sacred Heart Church in Crown Point where Penny serves as a member of the choir and David serves as choir accompanist.
