TOURNAMENT RULES AND REGULATIONS

All entrants must be members in good standing of the B.P.O. Elks to whom the tournament is restricted. THE SECRETARY OF EACH LODGE MUST CERTIFY THIS MEMBERSHIP.

The tournament shall be conducted in accordance with the Moral Support certification granted by the USBC. All games shall be played in strict compliance with the playing rules thereof.

USBC and Non-USBC members may participate in a Moral Support Certified Tournament with **HIGH SCORE** Recognition automatically extended to USBC members. Eligible NON-CERTIFIED members can qualify for HIGH SCORE RECOGNITION at their option by paying a \$21.00 fee prior to bowling for which USBC will issue an unattached membership card.

AN ENTRANT OR REPLACEMENT MAY BOWL ONLY ONCE IN EACH

EVENT. Substitutes provided by the HOST LODGE may bowl more than once but cash prizes will be paid to the original entrant only and the first score bowled will count for all their events.

Substitutions may be made at anytime but **NO SUBSTITUTIONS FOR SINGLES OR ALL EVENTS** may be made once an entrant or a replacement has started bowling in either event. No substitutions shall cause the original position of bowling of any other applicant to change.

The entering average for this tournament shall be the bowler's HIGHEST CERTIFIED LEAGUE AVERAGE, for a minimum of 21 games, for the 2018-2019 season. If a bowler's current season's average (minimum 21 games as of March 1st, 2020 is 10 pins or more above their average for the 2018-2019 season's average (minimum 21 games), current season average must be used. If a bowler has no average for the 2018-2019 Season, current season average at the time of entry for 21 or more games is to be used. If a bowler has no average for the 2018-2019 or 2019-2020 season, they must bowl scratch.

Averages for all winning scores will be verified by the Tournament Committee by Means of BOWL.COM SPORT AVERAGES ARE NOT ALLOWED.

IT IS THE RESPONSIBILITY OF EACH ENTRANT TO VERIFY THE ACCURACY OF THEIR AVERAGE AS SUBMITTED BY THE ENTRANT, A TEAM CAPTAIN OR OTHER. FAILURE TO USE THE PROPER AVERAGE OR MAKE A CORRECTION PRIOR TO THE COMPLETION OF THE FIRST GAME IN THE FIRST EVENT BOWLED SHALL] CAUSE THE SCORE TO BE DISQUALIFIED IF THE ACTUAL AVERAGE IS HIGHER THAN SUBMITTED. WHEN THE SUBMITTED AVERAGE IS HIGHER THAN THE AVERAGE, THE SUBMITTED AVERAGE WILL BE USED

Handicap for this tournament shall be 80% of the difference between the participant's entering average and 220 with a maximum of 70 pins per game allowed

Any participant who has qualified for a prize fund of \$200.00 or more in a tournament certified or uncertified within the 12 month period prior to the time of entry, must report those winnings IN WRITING, including the actual score, position of finish and the amount of the prize money won.

For this tournament, Rules 319E is not in effect.

ENTRANTS SHOULD REGISTER ONE HOUR PRIOR TO THE SCHED- ULED

TIME OF BOWLING. Any entry failing to appear at the lanes at the scheduled time shall forfeit the entry. Bowlers arriving late for any event will receive a "0" for the frames missed.

Tournament management will not permit any undue delay in the progress of any game and reserves the right to remove any participant from the lane for delay or other just cause.
