Dear Members

I hope everyone has had an enjoyable summer.

It seems good to be able to attend events again. Chairman David Brown and I recently visited Herkimer for their annual Car Show and it was great to see members of the Central District, especially without face coverings!

We've come so far since this health emergency was declared in March 2020. Let's hope that with the new COVID variants, we do not regress as a society,

As you know, the New York State Elks have partnered with the Cerebral Palsy Association of New York for the past 57 years, with all of your donations made to the Major Project going directly to the CP of NYS Home Service Program,

This has been a challenging year for all of us, but I know the NYS Elks will rise to that challenge. We are looking forward to hearing about all of your lodges' districts' events that are scheduled.

The Home Service Directors have been hit particularly hard during the pandemic and continue to 'reinvent the wheel' to serve their consumers. Usually, the grants are used for things like community gardens, music programs, or recreational equipment, but this past year your donations have been used to support the more essential aspects of CP's services. The Elks have supported Home Service Directors in addressing food scarcity, anxiety and depression during the pandemic.

The vehicle grants continue to be a very important part of the Home Service Program. From food delivery, to home visits and necessary transportation, NYS Elks vehicles have been instrumental in serving people with disabilities.

The Major Projects Corporation Board has announced a new Bequest and Living Trust Program. Many other states and organizations have instituted these as well and have had great success.

The way a Bequest and Living Trust (BLT) Program works is a bequest in a donor's will allows them to retain full control of their assets during their lifetime, and to receive an estate tax deduction. A bequest may be a percentage of the estate of a percentage of the remainder of the estate, and may be unrestricted or restricted for a specific purpose. There are four types of bequests that a donor can leave to a nonprofit **OT**

Residual - The remainder of the donor's estate after providing for their loved ones

Percentage or Fractional - A gift expressed as a percentage or fraction of the donor's estate,

Specific- A specified gift of money, property, or stocks and shares.

Whole Estate - Comprises a donor's entire estate. This is usually left by those without beneficiaries or those wanting: to achieve very significant impact.

The BLT allows for a few other ways in which donors can support the new Major Projects Board resolution:

Retained Life Estate A donor may make a gift of their home by deeding it to an organization while continuing to live there. The donor continues to be responsible for maintenance, insurance, and property taxes. In return, the donor receives an immediate tax benefit based on market value and IRS tables accounting for life expectancy, depreciation, and minimum tax rates.

Gifts from IRAS

Naming an organization as the beneficiary of an IRA, 401k, or defined contribution plan is an effective way to make a charitable gift. This avoids double taxation at the donor's passing.

Life Insurance There are two ways to make gifts of life insurance to an organization. A donor may transfer ownership of a policy, or purchase a policy with the organization as owner or beneficiary (this entitles the donor to tax deductions). Alternatively, a donor maintains ownership of the policy and their estate receives the tax deduction

I would like to thank our entire membership for all of your support for the past 57 years, and look forward to a long future working with Cerebral Palsy Association of New York to make all of the people with intellectual and developmental disabilities and their families' lives better.
