

Dear Members,

State Major Project Chairman David Brown (Brownie) will be making his final push for all members, lodges, and districts to make their per capita of \$8.00 per member. Without your donations, he would have a much tougher job. With all of the state and federal regulations handcuffing the Home Service Directors, the portion of their salaries that we provide, makes it possible to assist so many people with developmental disabilities. Your donations also assist with the annual purchase of three vehicles for the Home Service Directors. Each year the New York Elks Major Projects has a goal of \$400,000 to raise for our Major Project. But, in return, we give Cerebral Palsy of New York Home Service Directors \$456,700 annually in addition to our \$25,000 Grant Program. Also, keep in mind that you can process your donation online with a credit card. This is not only for Major Project, but also for your Elks National Foundation (ENF) donation. This is just a click away on the New York State website.

The Major Projects Board is working to implement a new program for the long-term sustainability of our commitment to the Home Service Program, our veterans, and youth programs. This new initiative is the New York Elks Major Projects, Inc. *Bequest and Living Trust Program (BLT)*. The Major Projects Board will be working to have a brochure in place in the coming months. CAMP BRISTOL UPDATE

Winter 2020 Edition

Winter, such as it is this year with temps up, then down, then up and down again. Then snow, or no snow, or snow again, or no snow. Or maybe rain, or not. Just like at your home this winter. All buildings were closed in for the winter, before the snows arrived. So all the general contractor has to do is actually get to the buildings: and then deal just with the cold---or not so cold depending on the day. Wow, what a winter. Crazy. The general contractor though does have his crew on site weather permitting to do interior work on the buildings. National Grid has installed a new utility pole on site and our electrical contractor has received approval of his work on installing the necessary equipment at that location so as to energize the individual buildings. Our contractor is now actually going building to building and making the necessary "connections" so that each building is "energized". Another giant step forward. Kitchen equipment is on order and when received the general contractor will begin installation (weather and snow accumulation permitting of course). Our engineers are working with the State Dept. of Health for approvals of final plans for water treatment. The wells were earlier approved along with the installation of the underground water/septic lines. Now the DOH has to give final approval of the actual treatment of the water itself for human use.

Important dates are now scheduled:

1—Spring Cleanup is May 31, we are hoping that this time the work load will be a bit easier. Sure hoping so. Great time for getting together for a great time. Start at 9 ish. We should be done (hopefully) by 1 ish.

2—Golf tournament is scheduled for June 20. Same location. Awards, food and such back at the camp

3—Grand Opening/Dedication is scheduled for August 1. Past Grand Exalted Ruler Dave Carr will be present. All members of the New York State Elks Association---that means YOU—are invited.

District Reps will have more information on the 3 activities as the dates draw closer. However, put these dates in your calendars now.






