NEW YORK STATE ELKS ASSOCIATION SPRING CONVENTION 2023 HIGHLIGHTS



The 109th Annual Convention of the New York State Elks Association and Spring Meeting of the New York Elks Major Projects, Inc. was held at the Villa Roma Resort in Callicoon, New York from May 18, 2023 to May 21, 2023. The convention was attended by members and quests representing Lodges from throughout the State. The convention began with an Opening Ceremony and Memorial Ceremony on Thursday evening, May 18th, 2023. The opening ceremony consisted of an invocation by Past State President Jamie Peace, the Pledge of Allegiance which was lead by East Central District SVP Merrill Connor, the Star Spangled Banner was song by Past District Deputy Mark Stuparich of New York Lodge #1, an introduction of Dias Dignitaries by provided by Past State President Tim Kelly, a welcome from East Central District Deputy Thomas Howley, a State Association welcome from State President Cam Ricci and remarks from the Honorable David R. On Friday morning, May 19th, State President Cam Ricci called the Opening Business session to order. An Invocation was provided by Past State President Jamie Peace, the Pledge of Allegiance by State Trustee Fritz Allen of Camillus Lodge #2367 and the National Anthem was song by Past District Deputy Mark Stuparich of New York Lodge #1. State President Ricci then introduced the Advisory Board members in attendance followed by remarks from Past Grand Exalted Ruler David R. Carr. This was followed by reports from the different committee chairs. Each outgoing Chair was presented a Recognition Award. Following the committee reports, there were nominations for State Vice Presidents, Trustees and State President. State President Kevin Connolly Installation Speech

GER Hidley, PGER Carr, Members of the Advisory Committee, fellow Elks, friends and family: I accept with humility the honor which has just been conferred upon me. I accept it with a resolve to do all that I can for the welfare of the New York State Elks Association and of the great Order of which we are a part.

In performing the duties of my office, I need the help and the prayers of every one of you. I ask for your encouragement and for your support. The tasks that many of our Lodge's face are difficult. We can best accomplish them by working together.

Each period of our history has had its special challenges. Those that confront us now are as considerable as any in the past. Today marks the beginning not only of a new set of officers, but of a period that will be eventful, and perhaps decisive, for us. Today, as I stand before you, I make the promise that I'm here to support the Elks that do the work that make Elks great.

My motto for this year is – Elks...Feel the Energy! Let me share what it means.

When I joined the Elks, I received a bizarre admonition from a cynical member, who, in retrospect, was probably feeling left out. When you help others, you feel good about yourself. When you help others, it changes lives for the better – it gives purpose & meaning, a hand-up. The BPOE and America itself were built not by people who relied on someone else to take care of them. They were built by American citizens who took charge of their own lives and had the courage to forge ahead with a sense of fairness. They did it with an unbeatable determination and enough boldness to take the necessary risks. Some would call this resourcefulness, individual enterprise, or backbone; whatever it may be called, that self-reliance is what characterizes Americans as Americans.

As we return to our Lodges and prepare for Flag Day, let's remember that it is our privilege to assert our American Patriotism and inspire it in others. Let it be visible in a way that encourages the next generation of leaders!
