My greetings to each and every New York State Elk! Marren and I wish you a wonderful holiday season and may your new year be blessed with good health, peace and happiness.

What an amazing year so far! I have visited 87 of 116 lodges at the time of writing my message and 7 more upcoming in December in the South District. I have been amazed in every district by the dedication of each officer and member. It is both enlightening and humbling to see the extent of the impact of Elks in our communities. I have had experiences that I will never forget and will cherish always. I thank you for the opportunity to meet with you all, it has been completely my honor. Meeting Elks in 'their own back yard' never fails to amaze me. Seeing the pride in your own lodges is inspirational.

I have seen not only your successes but you have shared your struggles, frustrations and challenges. It has given me an understanding of your concerns. I appreciate your trust in confiding in me. We can and should all learn from each other. Running a lodge is never easy. Those in leadership carry the burden of continued success against some against seemingly insurmountable odds. Many have old money pit buildings, declining membership, members unwilling to take officer positions, not enough volunteers, increasing bills and decreasing revenue and weather-related issues. We all face the same challenges. I know as my own lodge has experienced all of these at some point. Despite this, what about all the reasons we stay committed through and through? Do you see the faces of underprivileged children at your holiday event getting maybe their only gift for the season? Do you see the gratitude of families with food insecurities that we help? And the pride on other Elks faces when we are able to serve our active service members and Veterans? Yes it can be a struggle, but think about where would our communities be without Elks? I thank you all for the sacrifices you make.

As I travel and speak to each lodge I have shared my own personal story of how my pathway led me to be a US citizen, an Elk and now your NYS President. The American way of life, the way of life I chose, inspires me every day. I am grateful that fate led my path from England, coming for summer when I was 18, 38 years ago. I am not US born, but I believe in everything being a US Citizen and what being an Elk means. I will protect the honor of being both as my life's mission. I never knew back then how my life would change and how the impact of a quick decision at 18 for the summer all those years ago has led me to a life that I would never have imagined or dreamed of. Not only do I have a loving and amazing family, I have our Elks family that I am honored to be a part of and I strive every single day to do whatever I can to serve you and enable our organization to continue to flourish and be the force of good in our communities. Our work extends from providing immediate aid and long term help to those in need but also to uplift and empower individuals, to create a lasting legacy of kindness and volunteerism. Whether it's through local youth programs, initiatives for veterans, or other charitable endeavors, the Elks work tirelessly to ensure that New York's communities remain strong and resilient. I am proud to be United in Service with you.

I would like to speak to you about membership. We all know it is our life-blood and we must maintain and grow it to continue our good works and thrive and honor the legacy of those before us. I know when I ask people to join, more often than not, I am told they are too busy. I am sure you have the same responses. So let's try and think about this a little differently. Those folks surely are busy- they could be volunteering already with other organizations of if they have children they likely have them in every sport and activity known to mankind. And we certainly don't want them to sacrifice family, but how about we encourage them to join anyway?

Remind them that we still need dues paying members, it's a small donation to a cause that gives directly to their community. They can also support their lodge by buying a dinner here and there or maybe a raffle ticket. I know we are the few doing the most and it can be frustrating but let's think long term. Those same parents can maybe come for Hoop Shoot and see what the Elks are doing, maybe they can have date night and come have dinner and enjoy the benefits of the lodge. Their children need community service hours and scholarship opportunities. One day their children will spread their wings and the parents will have time on their hands. Maybe 10 years from now or even 20, they will consider a new phase of their life and they already have friends and membership in their local lodge. As frustrating as it can be, not everyone is able to volunteer at every level but we must still welcome them to our order. Your dues paying members of today may well be your officers of tomorrow.

On another note, consider the initiation of members at times other than meeting nights. I know many of us don't want to use up another evening or day but I did hear one compelling argument from GL Membership/Public Relations Manager Rick Gathen that compelled me to start thinking differently. We all know after a long regular business meeting including initiation, many members leave immediately following the meeting. If you have the initiation on a different day, it's a short meeting and then you can encourage your lodge officers and chairpersons to meet and greet the new members immediately after and this will be a time to recruit and welcome them. You can also orientate the candidates the same day, prior to the initiation, so they will be impressed not only by the information received there (don't forget to show them a couple of the great inspirational Grand Lodge You Tube Clips) and then by your Initiation. Thank you to all the lodges that initiated in November and December as part of the President's Challenge. I look forward to the presentations recognizing you at the Spring Convention.

As we have travelled we have taken donations for CP Home Services for card signing and we have been amazed at your generosity and look forward to announcing the final amount raised at the Spring Convention. We also raised money for Marren's charity which is Fearless!Hudson Valley. This is an organization that services my local counties to assist victims of domestic violence and abuse. Unfortunately this organization is overly busy in helping in both emergency situations and helping survivors gain and keep independence. As we have shared this with lodges, the reaction has been overwhelming. I have heard that many have been prior victims or knew someone near or dear to them who have been abused and even killed. I have heard from far too many of the impact of DV and how they now felt safe and loved in the Elks. Just another layer of why I love the Elks and their unending dedication to brotherly love. You are all such very special people. Remember to tell those you love their value and merit every single day.

In closing I thank you for your support, generosity and kindness this year and pray for our continued journey of strengthening our communities.

This past October, I attended the CP State Annual Conference along with State Major Projects Chairman David Brown, New Major Projects Board Member PSP Kevin Connolly, and PGER Bruce Hidley. I was honored to present the CP Person of the Year Award to PSP Kevin Connolly of Pearl River Lodge #2041.

Since 1964, our commitment to our Major Project has been the CP State Home Service Program, and the CP State conference is one of the two times a year that I meet with all of the Home Service Directors. I really wish our members could be in attendance, as our Home Service Directors and their Affiliates can't thank the New York State Major Projects enough. The Home Service Directors expressed that without our continued financial support, they would be unable to provide help and assistance to all the families they serve.


#### MAJOR PROJECT DONATIONS 2024-2025

It was a great summer with consistent reservations utilizing the full breadth of our rentals. Stay tuned for new 2025 season rental information coming soon!


### Camp Wedding

# Fall Golf Tournament & State Soccer Shoot






