He was an angel when I needed it the most. It made me believe once more in the love and care of a community. I will spend the rest of my life giving back whenever I can. By the way, I found out years later that mechanic was an Elk. Rest In Peace Liberty Elks member Danny Thalmann.

I want to thank each and every one of you for your dedication to the order and to each other. I am forever grateful for the trust you have placed in me and I intend to serve you and this organization as long as the Lord keeps me able to do so.

If you ever doubt the effect you are having locally go there and see thousands of like minded Elks doing what you are doing and together we are making a huge difference. My pride at conventions is beyond words.

I read an article just a short while ago and it rang so very true I want you to hear it. It was an article by Gary Fields, an award winning Associated Press journalist. He had tried to adopt his 13 year old orphaned nephew years ago from the inner city of Atlanta. The child's grandma wouldn't give him up as she was receiving a government check. Fields wondered how that child's life would have been different. That boy was shot to death by age 30 in the same ghetto he grew up in. Fields wrote, "I think about him often and the decision that kept him from reaching escape velocity, the things you need to go right to lift the weight of your birth circumstances off of you. Those include family, education, jobs, friends, neighborhoods, adult interventions, hard work and good luck. Even if they make it one step, a car repair, a missed day at work or a high utility bill can begin a downward spiral." He added, "I can't say for certain everything would have been OK but I believe we could have given him more options to a different path. What I want remembered is that changing his path would also have changed the lives of anyone he may have wronged, too".

That is powerful. That's what volunteerism does. It creates possibilities. It offers people the chance to change their story. You never know who you're going to impact — but you are impacting someone. A kind word to a senior who's isolated and lonely. A moment of time spent with a veteran who feels forgotten. A young person who sees a different path in life because you took the time to listen. Your service ripples out, affecting not just the person you directly help, but everyone they come into contact with.

During her visit to the Hudson Valley District, New York State Elks Association President Tania DeFrank had the opportunity to visit the City of Hudson Volunteer Fire Department. This is the oldest volunteer Fire Department in our state. State President Tania noted "I got to go in the fire truck and it was one of the best experiences ever! I literally held my breath when I got to push the button on the Q2B siren. What a thrill!!!! Thank you VP Christine. Volunteers are the best. Thank you City of Hudson FD". PAST STATE PRESIDENT JAMIE PEACE Major Project Message Winter 2025

It's hard to believe that we're in the final quarter of our lodge year. March is upon us, and our lodges will be nominating and electing their lodge officers for the upcoming year. I would like to thank all of the Exalted Rulers for all of their dedication and hard work during their terms.

Remember, it's not too late to make donations for your lodge's per capita for ENF and the NYS Elks Major Project. The final day for ENF is March 31st and for Major Project, May 31st. In order to receive many ENF grants, your lodge must have made its per capita. Also, please keep in mind that for your lodge to be eligible for future ENF grants, each year there are required forms to be completed and submitted to Grand Lodge for all grants received. As Major Project chairman David Brown works toward the \$400,000 goal, and lodges \$8.00 per capita, many lodges and districts are having events to help reach these goals. One upcoming event is being planned by Charles, one of our Ambassadors. Charles, along with his family, is sponsoring a meat raffle to help meet our goal. Last year Charles raised \$12,500 on this one-night event. Many lodges may want to take notice, as, unfortunately, we still have many lodges in the state that have zero per capita. Charles and his family understand how important the per capita is and want to do their part to ensure the Major Project is a success.

As was announced last year to help bring awareness to our membership, the New York Elks Major Projects awarded \$50,000 to NY Special Olympics. This award was distributed in all nine regions of New York state to support their regional and state programs. I will be attending the Special Olympics winter games in Rochester on February 21st and 22nd, as well as many Western Regional games this spring.

The Major Projects Boards's Benefactor Program is to make sure that the following programs are viable for many generations to come:

- Major Project Home Service Program through CP State
- Veterans Service Program
- Youth Programs

The idea behind the Benefactor Program is to motivate all Elks, their spouses, families, and friends to name the New York Elks Major Projects, Inc. in their will, living trust, insurance policy, annuities, or similar documents suggested by their financial advisor or attorney.

Giving is encouraged in any amount an individual can afford. The New York Elks Major Projects Board acknowledges that, for Elks, their first priority is to their families. They are asked only to donate surplus funds or holdings as a gift of love to the Major Projects. The Benefactor Program is designed to make it easy and affordable for everyone to give. At a recent District Deputy and State Vice President visitation, **Potsdam Lodge #2074** Exalted Ruler Ernie Charleston announced that the-Potsdam Lodge has donated \$8,000 in 2024-2025 to support the New York Stare Elks Association Major Project. With the donations, Potsdam has established a per capita of 8.98 per member. Lt. James Comstock from the Stamford CT Police Department and Mid-Westchester Lodge #535's Esteemed Lecturing Knight visited the scouts at the Bridge School at Cerebral Palsy of Westchester to put on a First Aid / EMS demonstration. The scouts participated in the first aid program called Stop the Bleed. Stop the Bleed is the result of a collaborative effort led by the American College of Surgeons Committee on Trauma (ACS COT) to bring knowledge of bleeding control to the public. The ACS COT, and specifically the EMS subcommittee with its many collaborative relationships, provided the perfect environment for this program to grow into the critical success that it is today. Learning to stop the bleed is a lifesaving skill. The number 1 cause of preventable death after injury is bleeding. With 3 quick actions, you can be trained and empowered to save a life. The scouts learned how to apply tourniquets and other life-saving skills to Stop the Bleed. Participating in the demonstration were 12 Cub Scouts and 12 Girl Scouts from Cerebral Palsy of Westchester's Bridge School. Members of our lodge arranged the program and helped the scouts with doing the first aid skills.

Seven members shopped for the food and nine were on hand for the food distribution which occurred at the Lodge prior to the Christmas Holiday. Members from the Lodge donated shopping carts and insulated bags in which the food was distributed. The carts were decorated with tinsel and a holiday card, signed by each cart's sponsor. 




