Recently I was reading a construction equipment sales magazine. The editor presented a commentary on turning buyers into repeat customers. She discussed customer satisfaction, loyalty, and the "Customer First" philosophy that all businesses should pay attention to. When I finished the article, it struck me that by substituting the word member for the term customer, I could easily relate the article to my lodge, specifically, to the relationship between members, who are our customers, and the leaders of our lodges.

Let me share some thoughts with you as I believe they apply to good business practice pertaining to the club aspect of our lodges, the business if you will. Keep in mind the thought: the member versus the customer.

1. We should strive to say "thank you" to our members. Consider this a "no brainer" if you will, but do we do it often enough?

2. Seek out member feedback and respond quickly to a member's request. This will be appreciated and returned in kind.

3. At all times remind members of the lodge's value to them. This will promote increased business.

 Treat member service costs as a good investment, not a needless expense to placate requests which may seem trivial.

5. Nurture and protect communication between members, officers, and chair persons. Good ideas come from friendly chats.

6. Promote useful dialogue between members and their leaders. I think at times our members may feel lesser than their leadership. Don't let this happen.

As leaders we must promote solid business practices. The way we treat our members is certainly one of them. Loyal members can be developed through respect and a keen awareness of our attitude toward them.
