With the Grand Lodge dues increase and the current financial stress our lodges are facing, the Trustees will use investment income as much as possible to cover those expenses above and beyond our existing income levels.

In preparing your budget for the 2009 - 2010 Lodge year, dues will remain at **\$1.25 per member.** 

This office still needs a copy of your Grand Lodge Membership report to accompany your per capita dues check. In the past, when we provided our State Association form, we had many conflicting totals to deal with. The NYSEA Dues must be calculated for the same number of members you are paying Grand Lodge dues per capita. Thank you.
